The Work for which the Bid is requested includes, but is not necessarily limited to, the furnishing of labor, materials and equipment for the construction of the SCWTP On-Site Chlorine Generation Improvements, including the following key components:

1. Demolition of the existing gas chlorine system and concrete floor
2. Demolition of the existing chlorine dioxide system
3. Installation of a new chlorine room concrete floor
4. Installation of new on-site chlorine generation units, tanks and ancillary equipment
5. Installation of new chlorine dioxide feed system and ancillary equipment
6. Associated electrical and control improvements

When a BIDDER submits a Bid, that Bid shall include the Schedule of Subcontractors, which shall identify each element of the Work to be subcontracted.

Each Bid shall contain evidence of BIDDER'S qualification to do business in the state of Colorado or covenant to obtain such qualification.

Each Bid must be accompanied by a Bid security consisting of a properly Certified Check, Cashier's Check, or Bid Bond, in the amount of five (5) percent of BIDDER'S Total Bid Price, without conditions, payable to the City of Louisville. Bid security will be retained by the City until the seventh day after the Effective Date of the Agreement whereupon Bid security furnished by such Bidder's will be returned. Bid security with Bids, which are not competitive, will be returned within fourteen days after the Bid opening. No Bid will be considered unless accompanied by such Bid security.

The successful BIDDER will be required to furnish a performance bond and a labor and material payment bond to the City of Louisville guaranteeing faithful performance and the payment of all bills and obligations arising from the performance of the Contract.

No Bid may be withdrawn within a period of sixty (60) days after the date fixed for opening Bids. The City of Louisville reserves the right to award the contract by sections, to reject any or all Bids, and to waive any informalities and irregularities therein.

The City of Louisville assumes no responsibility for payment of any expenses incurred by any respondent to this Invitation to Bid.

Preference is hereby given to materials, supplies, and provisions produced, manufactured, or grown in Colorado, quality and price being equal to articles offered by competitors outside of the State.

A mandatory pre-bid conference and job walk through with representatives of prospective BIDDERS will be held at **2:00 p.m.**, MDT at the Sid Copeland Water Treatment Plant, 1955 Washington Ave., Louisville, Colorado, on **June 27th, 2019** Representatives of the City will be present to discuss the Project. Perspective BIDDERS are invited to attend and present their questions relative to this Bid at this conference. **Attendance at this pre-bid conference will be required to submit a Bid.**
