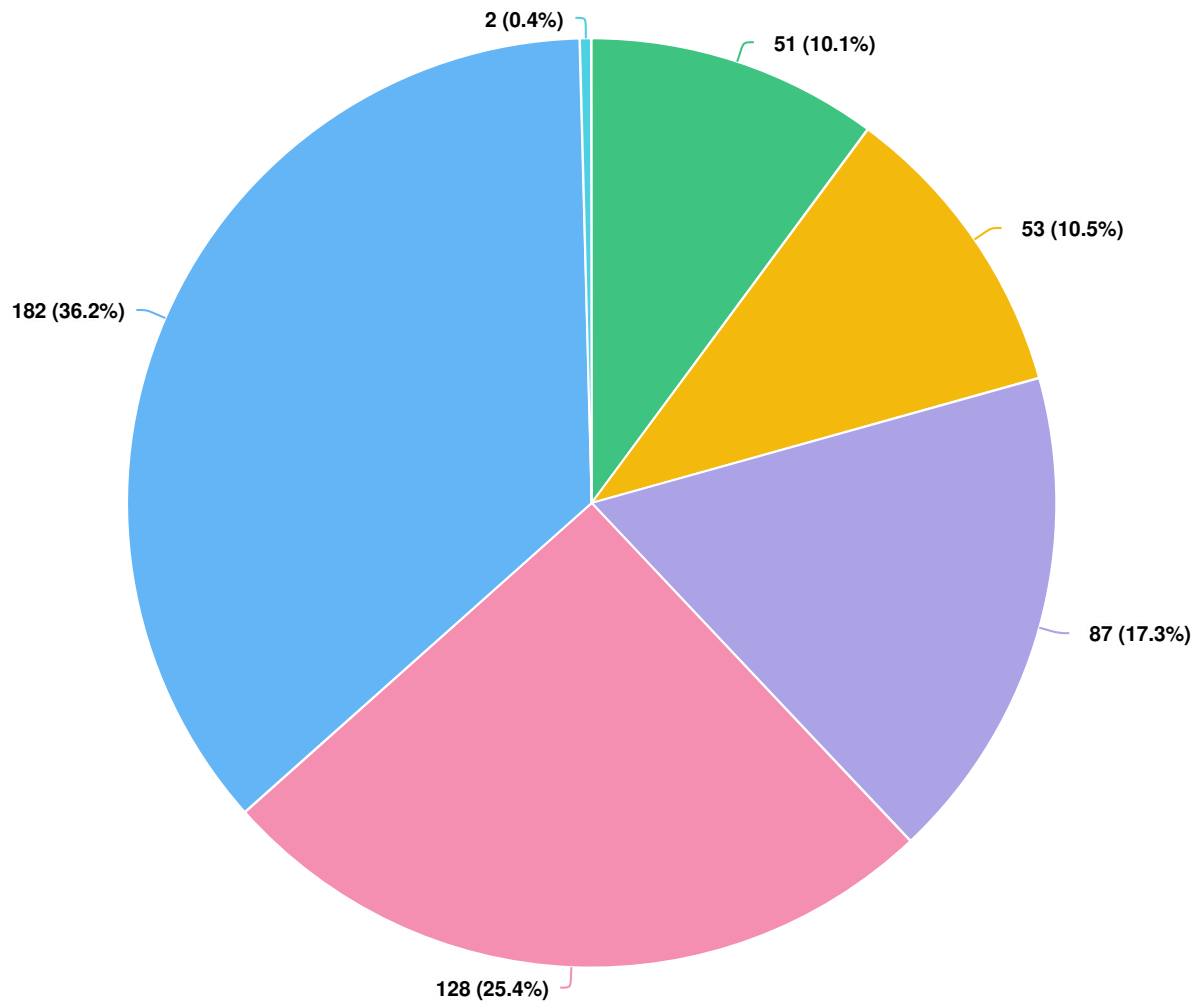

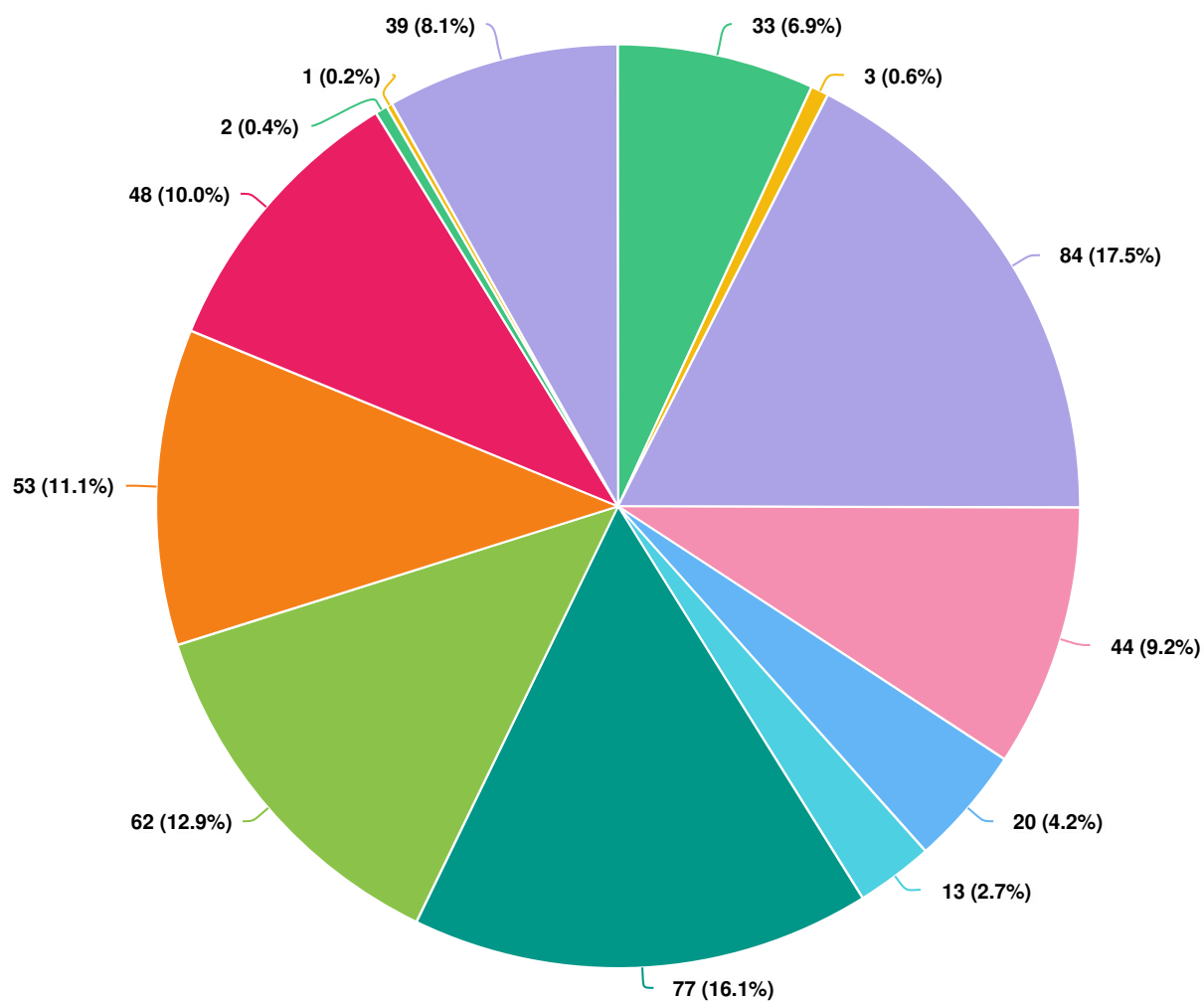

### Where is the affected property located?



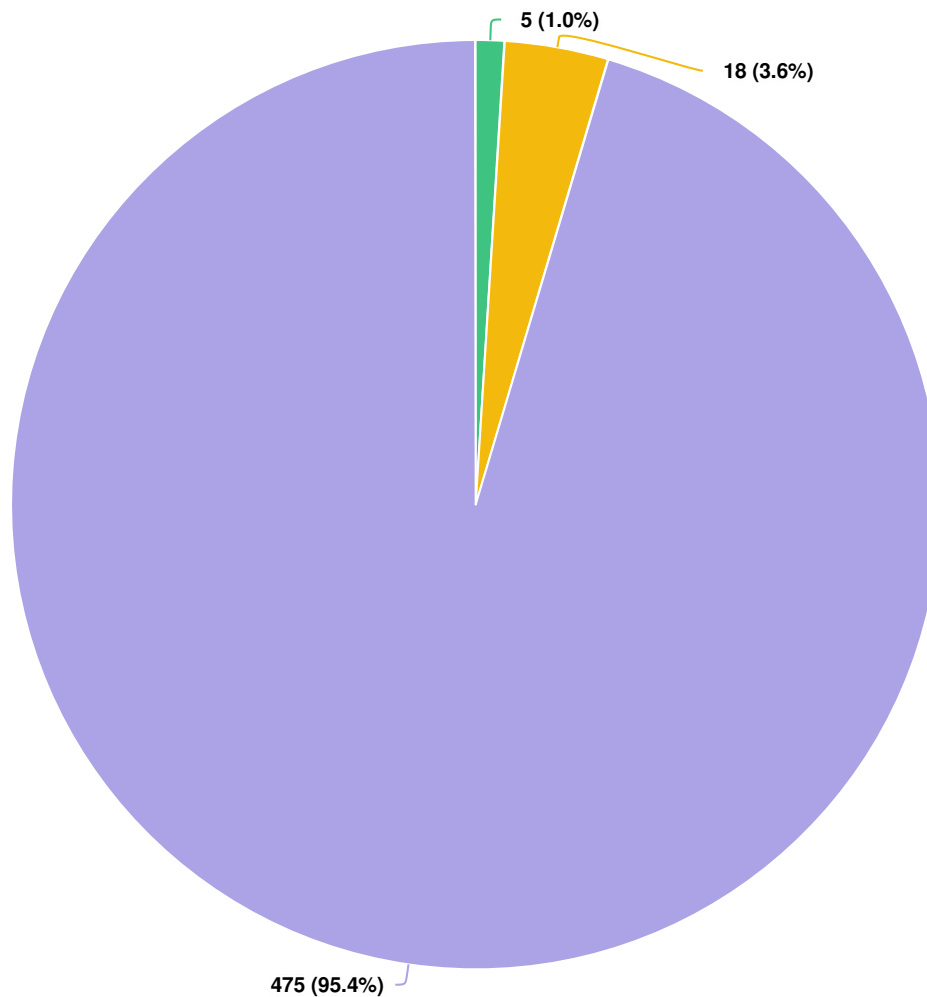

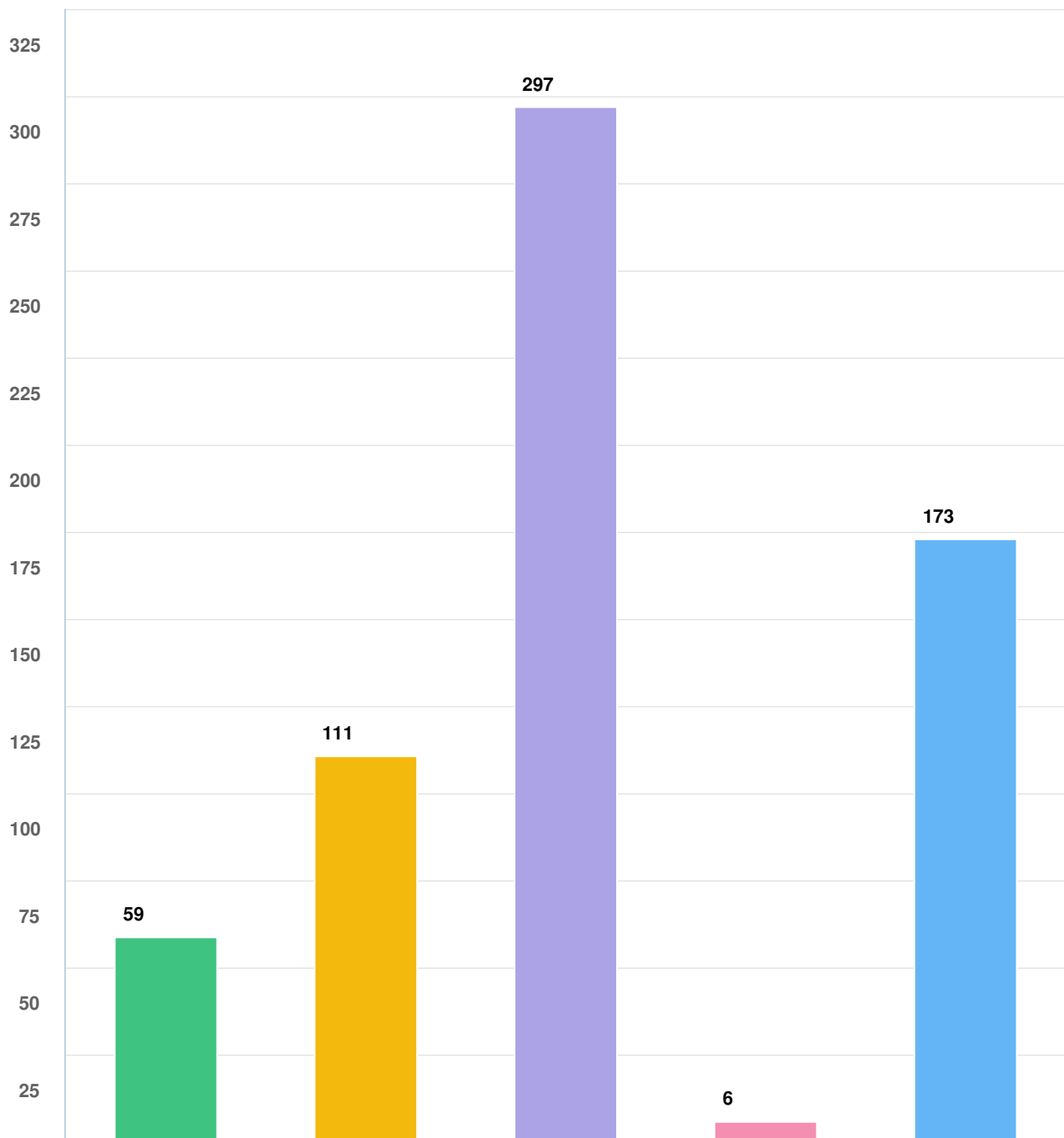

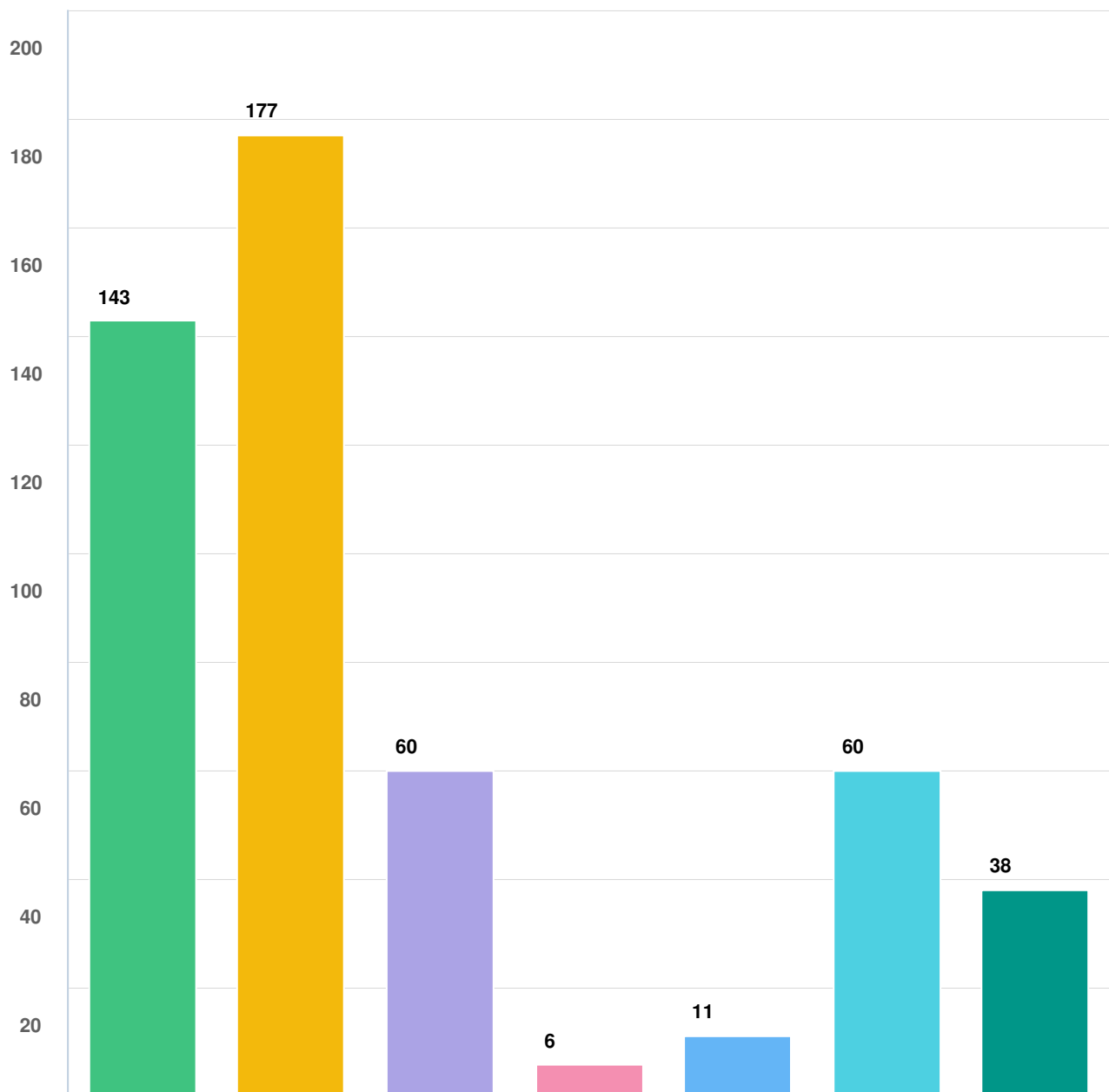

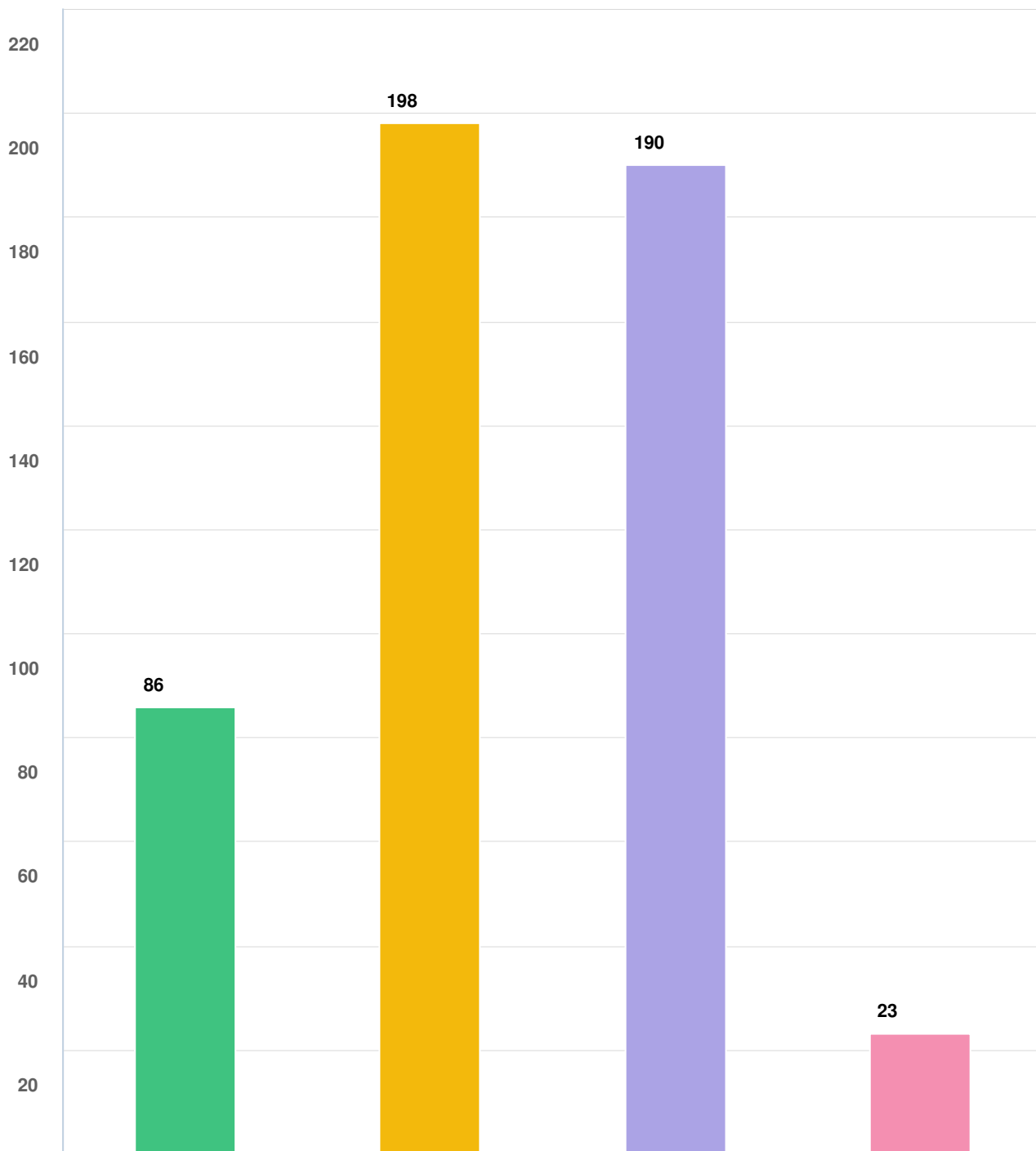
