Amelia - thanks for time this morning - I wanted to clarify some points ahead of the meeting this evening as I will be on Zoom. The questions I asked that might be helpful for the other HPC members to address included:

- Confirmed that the Applicant requested the finding of Probable Cause hearing (and this came after the sub-committee review),
- Confirmed that the Applicant was not required to landmark the property regardless of the outcome of the Probable Cause determination,
- Confirmed that if the Applicant chose to landmark the property they would be limited to preservation of the existing facade on Main Street (versus pursuing the currently planned design portrayed in the submission materials), and
- Confirmed that if the Applicant chose to landmark the property they could be eligible for a preservation grant award.

As we discussed the Applicant seems to be exploring options available to them regarding new design trade-offs or preservation with potential grant awards - which I think is an entirely reasonable course of action - but any insight provided from the Applicant and/or staff would be helpful this evening.
