

**SUBJECT: APPROVAL OF 2025 CITY COUNCIL APPOINTMENTS TO
BOARDS AND COMMISSIONS**

SUMMARY:

The City began soliciting applications for 2025 board and commission vacancies in October with a November 4 application deadline. The City Council appointed Mayor Pro Tem Dickinson and Councilmember Fahey to complete an initial review of the written applications. The Committee met and made recommendations for which applicants to move forward for an interview or an appointment. At the December 3 City Council meeting, the Council discussed the recommendations, altering the list slightly to include some additional interviews. On December 9 and 10 the Council met to interview 24 applicants for various board positions. Following the interviews, Council discussed the candidates' qualifications and merits and deliberated about possible appointments.

From that meeting the City Council now recommends the 2025 positions be filled as shown on the attached spreadsheet.

If the appointments are made as shown on the attached list there will be no vacant seats going into 2025.
